

## VAGABOND GOURMET - TERMS & CONDITIONS

### Deposits:

A deposit of \$600.00 per person is required to secure a booking. Reservations will be confirmed upon receipt of the deposits and a signed booking form. If the reservation is made within 60 days of the date of travel, full payment is due. If necessary deposit may be applied to another trip you need to cancel more than 60 days out.

### Final Payment:

**Vagabond Gourmet** must receive the final payment no less than 60 days prior to the first day of travel. Failure to do so may result in the reservation being cancelled.

### Single Supplements:

Accommodations are based on double occupancy. A single supplement is paid by guests who specifically request single accommodations, upon availability. If you are traveling alone and wish to share accommodations, we will try to match you with a roommate. However, if a roommate is not available, the forced single supplement will be charged which is 50% of the regular single supplement unless otherwise noted in the detailed itinerary.

### Payment Method:

**Vagabond Gourmet** accepts American Express, Mastercard or Visa credit cards, certified check, bank draft or money order. All payments are payable to **Vagabond Gourmet** and in United States currency.

### Travel Insurance:

Each **Vagabond Gourmet** tour has a predetermined minimum number of guests required. Please refer to the tour you are interested in for specific details. Neither **Vagabond Gourmet** nor its principles will be responsible for any expenses incurred due to cancellation of a tour. In the event a tour would need to be cancelled all monies paid to **Vagabond Gourmet** would be refunded, exclusive of airfares, rental cars or other expenses made independently.

It is highly recommended that you secure travel insurance.

### Cancellations:

Should you cancel 61 days or more before your original travel date no further payments are due. Cancellations 60 days or less will receive a 50% refund. All deposits and other payments will be available for use on future **Vagabond Gourmet** excursions. There can be no exceptions to this. Medical emergencies will be covered under travel insurance. No refunds will be given for attendees departing early.

### Itinerary Changes:

**Vagabond Gourmet** reserves the right to make changes to the itinerary. This will only happen when conditions or events arise that are out of the control of **Vagabond Gourmet**. All efforts will be made to ensure that the new itinerary is of the same "value". In any case, no refunds or discounts will be made due to any changes.

### Liability:

**Vagabond Gourmet** and Steven and Laura Schmalhorst will not be held responsible for cancellations, either from the participants or generated by **Vagabond Gourmet**, due to adverse weather conditions, war, and threat of war, civil strife, terrorism, or natural disaster. It is the responsibility of all persons participating in this tour to obtain sufficient travel insurance to protect their investment from but not limited to: medical expenses, baggage loss or damage, accidents, loss of personal property, cancellation and curtailment, personal liability, legal expenses and emergency. All ground transportation provided by **Vagabond Gourmet** will have independent third party insurance as required.
